- The statement of registration and the bond shall be filed with the secretary of state annually on or before July 1 of each year.
- The trading stamp company shall pay a registration fee of \$250.00 to the secretary of state at the time of filing each registration statement.
- The bond shall be effective for the registration year next following, unless the company gives notice of its intention to cease the distribution and redemption of trading stamps in this state.
