Please Note:

1. A Fantasy Sports Operator Registration must be filed prior to October 15th of each in year in which such operator offers a fantasy sports contest to consumers in this State.
2. A Fantasy Sports Operator Registration filed on or after October 15th of a given year shall expire on October 15th of the following year if not renewed prior to such expiration.
3. A Fantasy Sports Operator whose registration is effective may renew it for successive years by delivering to the Secretary of State a renewal application, between August 15th and October 15th of the preceding year. The renewal application, when filed, renews the registration through October 15th of the following year.
4. If the operator is a business entity, such entity must be in good standing with the Vermont Secretary of State at the time of registration or renewal.

- Part 1. Return Acknowledgement To - Required:** The Name and mailing address that this registration should be sent to by the Secretary of State following its processing by this office.
- Part 2.**
 - a. **Operator Name – Required:** The Operator Name must match exactly the name as it is authorized by the Secretary of State's Office.
 - b. **Business Location – Required:** The physical location where contest records will be maintained.
- Part 3. Filing Type –** Must indicate if this is a new filing, or a renewal of the previous year's filing.
- Part 4. Certification:** Form must be signed by one of the principals as listed on file with the Vermont Secretary of State's Office.
